TERMS OF REFERENCE

I. PROJECT TITLE: iHOMIS Server compliance

II. APPROVED BUDGET FOR THE CONTRACT: P 530,000.00 (Charged to TRUST FUND)

III. PROJECT DURATION: 30 days

IV. RATIONALE

Server is a piece of computer hardware or software (Computer Program) that provides functionality for other programs or devices. This can provide various functionalities, often called services; such as sharing data or resources among multiple clients or may connect over a network to a server on a different device.

Ballesteros District Hospital is currently using a Hospital Billing System (HBGys) under iHOMIS which is the HFI provider of the hospital in transporting our PHIC claims to PHILHEALTH. As such, the server is needed for our hospital for our Health Information System so that we can share data from other agencies and to the community.

V. This project aims the development of ICT infrastructure including provision of internet connectivity and network system in the Sub-Capitol.

VI. OBJECTIVES

The purpose of this Terms of Reference is to provide the supplier with the required specifications for server in compliance with the Department of Health minimum server requirements for iHOMIS.



However, if any dispute, controversy or difference cannot be resolved by them amicably to the mutual satisfaction of the parties, then the matter may be submitted for arbitration in accordance with existing laws, without prejudice for the aggrieved party to seek redress before a court of competent jurisdiction.

The guidelines contained in RA 9184 and its revised IRR shall be followed in the termination of any service contract. In the event the Province terminated the Contract due to default insolvency, or for cause, it may enter into negotiated procurement pursuant to section 53(d) of RA 9184 and it's IRR.
