GREETINGS:

WHEREAS, on June 09, 2020, the Undersigned rendered a Decision in the aboveentitled case, the dispositive portion of which reads:

"WHEREFORE, in view of the foregoing JUDGMENT is hereby rendered declaring that complainants were not illegally terminated or that they abandoned their work. As such, complainants must be reinstated back to work but without backwages. Moreover, respondents MSY TRADING and/or NANCY SY-Proprietress, are hereby ORDERED to pay complainants NELISA B. BUNAGAN, CLARISSA T. BACCAY and FE I. BALLESTA, the sum of ONE HUNDRED FORTY THOUSAND FIVE HUNDRED TWENTY-NINE PESOS & 40/100 (P140,529.40), Philippine Currency, representing unpaid salaries, salary differential, holiday pay, 13th month pay, service incentive leave pay and attorney's fees.

The reinstate ent aspect shall be immediately executory even pending appeal. Respondents are hereby ordered to show proof that they reinstated complainants within ten (10) calendar days from receipt hereof.

All other claims including damages are hereby DISMISSED for lack of basis.

SO ORDERED."

WHEREAS, on June 22, 2020, respondents thru counsel filed an Appeal Memorandum and posted an appeal bond in the amount of Php127,754.00 with O.R. No. 4940350 Y and deposit fees of Php658.77;

WHEREAS, on July 13, 2020, a Supplemental Appeal Memorandum was filed by the Respondents;

WHEREAS, on November 03, 2020, complainants thru counsel filed a Reply (To Appellant-Respondent's Appeal Memorandum);

WHEREAS, on January 19, 2021, the Fourth Division of the Commission promulgated a Decision, the dispositive portion of which, stated viz:

"WHEREFORE, the appeal filed by respondents is DISMISSED for lack of merit.

The Decision dated June 9, 2020 is AFFIRMED.

SO ORDERED."

WHEREAS, on June 23, 2021, respondents filed a Motion for Reconsideration;

WHEREAS, on September 07, 2021, the Fourth Division of the Commission promulgated a Resolution, the dispositive portion of which, stated viz:

"WHEREFORE, the Motion for Reconsideration filed by respondents is DENIED for lack of merit.

SO ORDERED."

WHEREAS, on January 05, 2022, an Entry of Judgment was issued certifying that the January 19, 2021 Decision affirming the Decision dated June 09, 2020, became final and executory on October 26, 2021;

WHEREAS, on April 29, 2022, complainants filed a Manifestation seeking separation pay as respondent failed to reinstate them back to work;

WHEREAS, on May 02, 2022, respondents were ordered to file their Comment on the Manifestation filed by complainants;

WHEREAS, respondents failed to file their Comment on the Manifestation of complainants; as such since respondent failed to reinstate complainants, they should be entitled to separation pay;

WHEREAS, on June 24, 2022, the Writ of Execution was issued;

WHEREAS, in the said Writ of Execution the separation pay of Clarissa T. Baccay was not included in the computation. Hence, this **Amended Writ of Execution**.

NOW THEREFORE, you are hereby commanded to collect, in accordance with Section 9, Rule XI of the 2011 NLRC Rules of Procedure, as amended, the total sum of Two Hundred Twenty Seven Thousand Six Hundred Forty-Nine Pesos & 40/100 (Php227,649.40), Philippine Currency, representing unpaid salaries, salary differential, holiday pay, 13th month pay, service incentive leave pay, separation pay and attorney's fees from respondents MSY TRADING and/or NANCY SY-Proprietress located at Luna St., Centro 3, Tuguegarao City, Cagayan or anywhere in the Philippines where they may be located. 1

Further, collect from respondents the Execution fees of Php1,776.49 and Deposit fees of Php499.50 only considering that respondents already deposited an amount of Php658.77 pursuant to the 2012 Sheriffs' Manual on Execution of Judgment. Thus, you are to collect the total amount of Two Hundred Twenty Nine Thousand Nine Hundred Twenty-Five Pesos & 39/100 (Php229,925.39), Philippine Currency. Any amount collected shall be deposited to the Cashier of this Office for proper disposition.

In case you fail to collect the amount above-mentioned from respondents, or the amount collected is insufficient to satisfy the judgment award, you are hereby ordered to cause the satisfaction of the judgment award in accordance with the order of enforcement stated in Section 9(a) Rule XI of the 2011 NLRC Rules of Procedure, as amended to wit: (a) Cash Bond; (b) Bank Deposits; (c) Surety Bond; (d) Personal Properties of the respondent not exempt from execution; and (e) Real Properties of respondent.

If the bonding company refuses to comply with the Writ of Execution, you may proceed to levy on the personal properties, and if insufficient, the real properties of the bonding company, without prejudice to contempt proceedings against its officers or authorized representatives.
